## NCC SPECIAL ENTRY SCHEME: COURSE COMMENCING IN JANUARY 2018

- Online applications are invited for the courses commencing in January 2018 for grant of Permanent Commission (PC) for Men and Short Service Commission (SSC) for Men & Women in Flying Branch.
- Eligibility criteria is as given in the table:-

- \* Criteria for post LASIK surgery for Flying Branch are as follows:-  
(i) Candidates who have undergone PRK (Photo Refractive Keratotomy)/LASIK (Laser in Situ Keratomileusis) may be considered fit for commissioning in Air Force Flying branch.  
(ii) Post PRK/LASIK candidates must meet the visual requirements required for the branch as laid down in Para 3.12.5.2 IAP 4303(4<sup>th</sup> edition).  
(iii) The following criteria must be satisfied prior to selecting post-PRK/LASIK at the time of Air Force Medical Examination.  
(aa) PRK/LASIK surgery should not have been carried out before the age of 20 years.  
(ab) The axial length of the eye should not be more than 25.5 mm as measured by IOL master.  
(ac) At least 12 months should have elapsed post uncomplicated stable PRK/ LASIK with no history or evidence of any complication.  
(ad) The post LASIK corneal thickness as measured by a corneal pachymeter should not be less than 450 microns.  
(ae) Individuals with high refractive errors (>6D) prior to LASIK are to be excluded.  
(af) Radial Keratotomy (RK) surgery for correction of refractive errors are not permitted for any Air Force duties. Candidates having undergone cataract surgery with or without IOL implants will be declared unfit.

Note: LLB qualified candidates (after commissioning) may get an opportunity to be employed on legal duties of the IAF.

- Candidates appearing in final year/semester examinations may apply for course commencing in January 2018 provided they fulfil the following conditions:-

- Candidates should not have any present backlog and should have secured a minimum of 60% marks upto the last semester / year for which results have been declared at the time of online submission and at the time of AFSB.
- Candidates should be able to provide provisional / original degree certificate issued by University latest by 15 November 2017.

### TYPE OF COMMISSION.

- (a) **PC for Men.** Candidates joining as PC officers would continue to serve till the age of superannuation.  
(b) **SSC for Men & Women.** The Engagement period for SSC Flying Branch is Fourteen years from the date of Commissioning (Not extendable).

### SELECTION PROCEDURE

- All applicants whose applications are submitted by due date will be called for testing at one of the Air Force Selection Boards (AFSBs) at Dehradun, Mysore, and Varanasi. The testing would consist of three stages as given below:-

- Stage-I.** Officer Intelligence Rating Test along with Picture Perception and discussion Test will be conducted on the first day. Stage-I test is a screening test and only those who qualify would undergo subsequent testing. All Stage-I qualified candidates would be subjected to document check to ascertain their eligibility for NCC Special Entry Scheme applied for. Those candidates who either do not qualify in Stage-I or do not meet the required eligibility criteria would be sent back on the first day itself.

- Stage-II.** Testing consisting of Psychological, Group Tests and Interview will commence after document check for the next five days.

- Computerised Pilot Selection System (CPSS) would be administered to recommended candidates only. This is once in a lifetime test. **Candidates who have failed the (CPSS)/PABT in an earlier attempt or a Flight Cadet suspended from flying training at Air Force Academy will not be eligible to apply.**

- Change of Interview Dates.** Request for change of AFSB interview date should be avoided. However, as an exception, such change may be considered based on the circumstances of the case. Request for such change should be forwarded to the respective AFSB where the call letter has been issued. The AFSBs may consider change of date at their discretion. E-mail ID and telephone numbers of AFSB centres / contact details of AFSBs are available under the link of contact us at Indian Air Force website [www.careerairforce.nic.in](http://www.careerairforce.nic.in).

- Medical Examination will be conducted at AFCME, New Delhi/ IAM Bengaluru based on the recommendations at AFSB. Non reporting of candidates on allotted date for medicals could lead to cancellation of candidature.

- Candidates recommended by the AFSBs and declared medically fit will be detailed for training if the candidates qualify in the final merit list depending on the number of vacancies available in branch.

- No compensation will be paid in respect of any injury sustained during the testing at AFSB.

- Onus of meeting the eligibility criteria rests with the applicant. Merely undergoing AFSB testing would not constitute fulfilment of eligibility requirements.**

- How to Apply.** If you meet the eligibility criteria, please click on "CANDIDATE LOGIN" in the career website of IAF [www.careerairforce.nic.in](http://www.careerairforce.nic.in) and follow the instructions. You are advised to note down Registration number for future correspondence. Candidates are advised to read the notification and the detailed guidelines for filling up online application as given in the website prior to commencement of filling up online applications. While filling online application, it is advisable to keep the relevant documents readily available, as details are to be filled as per matriculation and other educational certificates. Please save your recent colour passport size photograph (size 10 to 50 KB) for uploading it with your online application form. Also save your NCC 'C' Certificate, for uploading (size 1 MB). Please note that utmost care needs to be taken while filling up the online application. In case any information is found to be incorrect, the candidature is likely to be cancelled at any stage of the selection process. **Submission of more than one application will result in cancellation of candidature.**

- Final submission of application form.** Application will be accepted once the NCC Certificate is validated by Dte of NCC

### Notes.

- Candidates who are debarred by the Ministry of Defence from holding any type of commission in Defence Services shall not be eligible to apply for examination and if admitted, their candidature will be cancelled.

- Candidates who have withdrawn/suspended from Defence Training Establishments on grounds of discipline are not eligible to apply.

- Serving Airmen.** Serving Airmen are required to apply online at par with other candidates. In addition, Airmen candidates would be required to apply as per the service format as given in AFO 11/ 2015 through service channel. Other government employees also need to apply online after obtaining necessary permission from their concerned departments and they are to produce NOC at the time of AFSB testing.

### TRAINING.

- Training is scheduled to commence in the first week of January 2018.

- The duration of training for Flying Branch is 74 weeks at Air Force Training Establishments.

### IAF OFFERS YOU.

- Pay and Allowances.** A Flying Officer will be entitled to Pay in Pay Band of ₹ 15,600 - 39,100 per month along with Grade Pay, Military Service Pay, Dearness Allowance, Kit Maintenance Allowance, Transport Allowance. In addition, other allowances are applicable based on nature of duty / place of posting and would include Flying Allowance, Field Area Allowance, Special Compensatory (Hill area) Allowance, Special Force Allowance, Siachin Allowance, Island Special Duty Allowance, Test Pilot & Flight Test Engineer Allowance, Area Allowance and Remote Locality Allowance. On successful completion of Training, newly commissioned Flying officers would be entitled to approximate gross monthly emoluments in different branches including Transport Allowance of major cities as follows:-  
**Flying Branch:- ₹ 82,050/-**

Note: The pay and allowances are subject to enhancement based on implementation of VII CPC.

- Benefits.** In addition to the Pay & Allowances, officers are entitled to furnished accommodation, comprehensive medical cover for self and dependents, supply of entitled rations, Canteen & Officers' Mess facilities and many more. LTC and Leave (60 days Annual and 20 days Casual) subject to service exigency.

- Insurance.** ₹ 75 Lakh Insurance Cover (on contribution) is applicable to serving officers. Additional cover of ₹ 10 Lakh (on contribution) is applicable to Flying Branch Officers.

- Travel Allowance (TA).** To and fro travelling fare by the shortest route of AC-III Tier/AC Chair Car or actual normal bus fare to the candidates appearing in AFSB for the first time will be reimbursed. Change of address, if any, must be intimated to the Board well before your arrival. You shall furnish the railway ticket/ bus ticket (hard copy) to the Board, failing which no TA will be paid. For all other modes of travel, TA will be admissible as per the government authorized rules. **No TA is admissible, if you have already appeared for the same type of entry at any of the Selection Boards.**

### IMPORTANT INSTRUCTIONS

- In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks would be based on the procedure certified by the University from where they have obtained the degree. In case the University does not have any scheme for converting CGPA to percentage conversion certificate, CGPA will be converted into 10 points scale and multiplied by 10 to get equivalent percentage.

- Candidates are required to maintain their unique E-Mail ID active throughout the selection process.**

- Candidates below 25 years of age must be unmarried (term unmarried excludes widower and divorcee even though without encumbrances). Marriage is not permitted during training. Married candidates above 25 years of age are eligible to apply but during training period they will neither be provided married accommodation nor can they live out with family.

- Permanent body tattoos are only permitted on inner face of forearm i.e. from inside of elbow to the wrist and on the reverse side of palm/ back (dorsal) side of hand. Permanent body tattoos on any other part of the body are not acceptable. Tribes with tattoo marks on the face or body as per their existing custom and traditions will be permitted on a case to case basis.

- Candidate should not have been arrested, convicted or prosecuted on criminal charges.

- Candidates must carry call letter and a valid photo identity card such as passport, driving licence, voter identity card, college identity card or any other valid photo identity proof while reporting to AFSB Interview. **The onus is on the candidate to produce the valid proof of identity which authenticates name and the date of birth mentioned in Call letter.**

- The candidature for the courses commencing in January 2018 will be valid only if the proof of meeting eligibility criteria is submitted latest by 15 November 2017.

- PAN Card is a mandatory requirement to join AFA.

- Online modification of submitted applications may be carried out for name (spelling) and address only on 16 & 17 Jun 2017. Please note that information filled up by the candidates in online application form will be considered final and no amendments will be allowed subsequently.

- After admission to Air Force Academy, candidates will not be considered for any other commission. They will also not be permitted to appear for any interview or examination after they join for training in the Air Force Academy.

- Candidates would be given joining instructions for joining the AFA. No other intimation would be given till final merit list is prepared. A candidate would have to make it in the final cut off merit list after AFSB recommendations and medical examination, to be eligible for joining Indian Air Force.

- Physical Conditioning.** Prospective candidates are advised to keep themselves in good physical condition to adapt to physical training at AFA which encompasses running, swimming, rope climbing and other forms of physical training / conditioning in which they would undergo mandatory tests during training.
